WHEREAS, on May 5, 2014, by Roll Call No. 14-0734, the City of Des Moines endorsed the Capital Crossroads Capital Core Neighborhood Improvement Implementation Plan, which lists proactively addressing blighted residential properties and revitalizing neighborhood commercial areas as two of five strategic initiatives; and

WHEREAS, the Center for Community Progress, a national non-profit organization solely dedicated to helping communities develop solutions to address blighted, vacant, and other problem properties, is seeking applications from public entities that want to assess, reform, develop, and/or implement systems to address the issue of vacant and blighted properties in their community; and

WHEREAS, the Center for Community Progress will select up to four communities to receive up to 200 donated hours of technical assistance in 2015; and

WHEREAS, the City will request assistance to investigate the root causes leading to vacant and blighted properties in Des Moines, including an assessment of current local policies, systems and practices, and recommend an implementation plan for more effectively and efficiently addressing the issue.
