RESOLUTION APPROVING DES MOINES AREA METROPOLITAN PLANNING ORGANIZATION AMENDED AND SUBSTITUTED ASSESSMENT TO THE CITY OF DES MOINES FOR FISCAL YEAR 2015/16

WHEREAS, the City of Des Moines is a member of the Des Moines Area Metropolitan Planning Organization ("MPO"), as organized under Iowa Code Chapter 28E; and

WHEREAS, on June 8, 2015, by Roll Call No. 15-0929, the Des Moines City Council approved the Des Moines Area Metropolitan Planning Organization's Unified Planning Work Program and budget for Fiscal Year 2015/16, beginning July 1, 2015, and authorized and directed the Finance Department to pay the City's assessment of \$203,433 to the MPO when due; and

WHEREAS, the City of Des Moines received an amended and substituted Des Moines Area Metropolitan Planning Organization Fiscal Year 2016 assessment in the amount of \$204,220 on June 18, 2015; and

WHEREAS, the budget to support the Unified Planning Work Program is funded with federal funds and member governments on a per capita basis; and

WHEREAS, the assessment rate of MPO member governments for Fiscal Year 2015/16 is set at \$1.00 per capita, and when applied to the 2010 corrected Census of Population for the City of Des Moines as furnished by the Bureau of the Census March 20, 2013 and filed with the Office of the Iowa Secretary of State in February 2014, equates to an assessment of \$204,220 to the City of Des Moines; and

WHEREAS, the City Manager has recommended that the amended and substituted DMAMPO assessment to the City of Des Moines for Fiscal Year 2015/16, be approved.

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the Des Moines Area Metropolitan Planning Organization's amended and substituted DMAMPO assessment to the City of Des Moines for Fiscal Year 2015/16, beginning July 1, 2015, is hereby approved, and the Finance Department is hereby authorized and directed to pay the City's assessment of \$204,220 to the MPO when due.
