WHEREAS, on April 20, 2009, by Roll Call No. 09-693, the City Council approved an agreement with Holland & Knight, LLP, to provide professional federal government affairs services with an initial term of one year, with up to three one year renewal options upon mutual consent of both parties; and

WHEREAS, on April 26, 2010, by Roll Call No. 10-617, the City Council approved a one year renewal of the agreement, on May 9, 2011, by Roll Call No. 11-0801, the City Council approved a one year renewal of the agreement, and on May 7, 2012, by Roll Call No. 12-0707, the City Council approved a one year renewal of the agreement; and

WHEREAS, on June 10, 2013, by Roll Call No. 13-0912, the City Council approved a new agreement with Holland & Knight, LLP, to provide professional federal government affairs services with an initial term of one year, with up to three one year renewal options upon mutual consent of both parties, in the amount of \$8,000.00 per month for the initial year and first two renewal years and \$8,500.00 per month for the third renewal year, plus travel and expenses; and

WHEREAS, on June 23, 2014, by Roll Call No. 14-0974, the City Council approved a one year renewal of the agreement, which expired on April 30, 2015; and

WHEREAS, the City and Holland & Knight, LLP, desire to renew the agreement until April 30, 2016.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the City Manager is authorized and directed to execute the second one year renewal agreement with Holland & Knight, LLP, for and on behalf of the City of Des Moines, subject to approval as to form by the Legal Department, and the City Clerk is authorized to attest to his signature; and
