RESOLUTION AUTHORIZING THE REDEMPTION OF
OUTSTANDING GENERAL OBLIGATION BONDS, SERIES
2008D AND GENERAL OBLIGATION BONDS, SERIES 2008E
(URBAN RENEWAL), OF THE CITY OF DES MOINES, IOWA,
DATED JUNE 23, 2008, AND DIRECTING THAT NOTICES OF
REDEMPTION BE GIVEN

WHEREAS, the City Council has heretofore, by Roll Call No. 08-1059 approved on June 9, 2008, authorized the issuance of \$24,055,000 General Obligation Bonds, Series 2008D, dated June 23, 2008 (the "Series 2008D Bonds"); and

WHEREAS, the Series 2008D Bonds maturing after June 1, 2016 may be called for redemption and paid before maturity on said date or any date thereafter, from any funds regardless of source, in whole or from time to time in part, upon giving notice in the manner provided in the foregoing resolution authorizing the issuance of the Series 2008D Bonds; and

WHEREAS, the City Council has heretofore, by Roll Call No. 08-1060 approved on June 9, 2008, authorized the issuance of \$6,325,000 General Obligation Bonds, Series 2008E (Urban Renewal), dated June 23, 2008 (the "Series 2008E Bonds"); and

WHEREAS, the Series 2008E Bonds maturing after June 1, 2016 may be called for redemption and paid before maturity on said date or any date thereafter, from any funds regardless of source, in whole or from time to time in part, upon giving notice in the manner provided in the foregoing resolution authorizing the issuance of the Series 2008E Bonds; and

WHEREAS, it is deemed necessary and advisable that the Series 2008D Bonds and the Series 2008E Bonds be so redeemed and that notices of redemption be given.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA:

Section 1. That outstanding General Obligation Bonds, Series 2008D, dated June 23, 2008, in the principal amount of \$17,430,000, be and the same are hereby redeemed as of June 1, 2016.

Section 2. That outstanding General Obligation Bonds, Series 2008E, dated June 23, 2008, in the principal amount of \$3,435,000, be and the same are hereby redeemed as of June 1, 2016.

Section 3. The Finance Director/Treasurer is hereby authorized and directed to cause to be deposited in a separate fund, from the proceeds of the General Obligation Refunding Bonds, Series 2015B, dated the date of delivery, an amount sufficient to pay all principal of the redeemed Series 2008D Bonds and the Series 2008E Bonds on the date of redemption.
