HOLD HEARING FOR VACATION OF A PORTION OF EAST MARKET STREET RIGHT-OF-WAY ADJOINING 111 SE 7TH STREET AND FOR CONVEYANCE OF A BUILDING ENCROACHMENT EASEMENT TO THOMAS A. PIKE FOR \$1,500

WHEREAS, on June 18, 2015, the City Plan and Zoning Commission voted to approve a request from Thomas A. Pike to vacate a portion of East Market Street adjoining 111 SE 7th Street (herein "City Right-of-Way"), to accommodate an existing building encroachment, and on July 13, 2015, the City Council of the City of Des Moines by Roll Call No 15-1139, received and filed a communication relating to said recommendation from the Plan and Zoning Commission; and

WHEREAS, Thomas A. Pike is the owner of the real property locally known as 111 SE 7th Street, which property abuts the City Right-of-Way, and has offered to the City of Des Moines the purchase price of \$1,500.00 for the vacation of the City Right-of-Way and purchase of a building encroachment easement interest in the City Right-of-Way to accommodate an existing building encroachment into and upon the City Right-of-Way, which purchase price reflects the fair market value of the easement as currently estimated by the City's Real Estate Division; and

WHEREAS, there is no known current or future public need or benefit for the City Right-of-Way proposed to be vacated, and the City will not be inconvenienced by the vacation and conveyance of a building encroachment easement interest in said property as described herein; and

WHEREAS, on July 13, 2015, by Roll Call No. 15-1138, it was duly resolved by the City Council that the proposed vacation and conveyance of such easement be set down for hearing on July 27, 2015, at 5:00 p.m., in the Council Chamber; and

WHEREAS, due notice of said proposal to vacate said City right-of-way and convey the encroachment easement was given as provided by law, setting forth the time and place for hearing on said proposal; and

WHEREAS, in accordance with said notice, those interested in said proposed vacation and conveyance, both for and against, have been given an opportunity to be heard with respect thereto and have presented their views to the City Council.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, as follows:

- 1. Upon due consideration of the facts and statements of interested persons, any and all objections to said proposed vacation and conveyance of the subsurface easement as described below are hereby overruled, and the hearing is closed.
- 2. There is no public need or benefit for the right-of-way proposed to be vacated, and the public would not be inconvenienced by reason of the vacation of a portion of East Market Street adjoining 111 SE 7th Street, more specifically described as follows:
