CONSENT TO ASSIGNMENT OF ECONOMIC DEVELOPMENT AGREEMENT TO MDM EQUITY – 2012, LLC, FOR COMPLETED PROJECT AT 505 EAST GRAND AVENUE

WHEREAS, on April 21, 2014, by Roll Call No. 14-0628, the City Council approved an Urban Renewal Development Agreement (the "Agreement") with 505 East Grand, LLC (the "Developer"), represented by Jake Christensen, whereby the Developer agreed to redevelop the property at 505 E. Grand Avenue with a new 2-story building at least 40 feet in height and containing at least 18,000 square feet of finished floor area for retail/commercial uses, with offstreet parking, landscaping and streetscape improvements, and the City agreed to provide an economic development grant to Developer payable in 11 annual installments commencing on December 1, 2017; and,

WHEREAS, on July 27, 2015, by Roll Call No. 15-1254, the City Council approved the issuance of a Certificate of Completion to the Developer to acknowledge the Developer's completion of the project in substantial compliance with the Agreement and the approved Conceptual Development Plan; and,

WHEREAS, Developer has proposed to assign of all its rights and obligations under the Agreement to MDM Equity – 2012, LLC, an lowa limited liability company (the "Assignee") represented by Kaar Field, its Manager-President, and although the Agreement is freely assignable after issuance of the Certificate of Completion, the Developer has requested the City formally approve such assignment.

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, lowa, that the proposed assignment is hereby approved, and the Mayor and City Clerk are hereby authorized and directed to execute the *Acceptance and Approval* of the assignment described above.


