## RESOLUTION SETTING HEARING ON REQUEST FROM KUM & GO, LC FOR AMENDMENT TO THE KUM & GO STORE #120 PUD CONCEPTUAL PLAN ON PROPERTY LOCATED AT 6304 SOUTHWEST $9^{\text{TH}}$ STREET

WHEREAS, on July 23, 2012, by Roll Call No. 12-1193, the City Council adopted Ordinance No. 15,122, to rezone real property located in the vicinity of 6304 Southwest 9<sup>th</sup> Street ("Property") from "C-2" General Retail and Highway Oriented Commercial District and "R1-60" One-Family Low-Density Residential District to "PUD" Planned Unit Development District classification for the Kum & Go Store #120 PUD District; and
