CONSENT TO LEASEHOLD MORTGAGE TO COMMUNITY STATE BANK OF THE LEASE BETWEEN THE CITY AND BERGMAN ACADEMY OF THE LEASED PROPERTY AT 100 45<sup>TH</sup> STREET

WHEREAS, on March 24, 2008, by Roll Call No. 08-515, the City Council approved a lease of the Greenwood Building at 100 45<sup>th</sup> Street (the former Science Center of Iowa Building) to Bergman Academy (f/k/a Iowa Academy), to operate a non-profit school, and to construct significant improvements to such building for an initial term of 20 years with two renewal periods of 10 years, upon mutual agreement of the parties; and

WHEREAS, on July 11, 2015, by Roll Call No. 15-1177, the City Council approved an Addendum and Amendment to Lease Agreement which allows Bergman Academy to construct at its expense a two story addition to the Greenwood Building to add eight (8) classrooms, including an elevator to service the existing building and the addition, and to construct a free—standing gymnasium/multipurpose building, with an estimated cost of Four Million Seven Hundred and Seventy-Five Thousand Dollars (\$4,775,000) and which also extends the initial term of the Lease Agreement until December 31, 2044, for the leased premises as described below:
