RESOLUTION HOLDING HEARING ON REQUEST FROM KUM & GO, LC FOR AMENDMENT TO THE KUM & GO STORE #120 PUD CONCEPTUAL PLAN ON PROPERTY LOCATED AT 6304 SOUTHWEST 9TH STREET

WHEREAS, on July 23, 2012, by Roll Call No. 12-1193, the City Council adopted Ordinance No. 15,122, to rezone real property located in the vicinity of 6304 Southwest 9th Street ("Property") from "C-2" General Retail and Highway Oriented Commercial District and "R1-60" One-Family Low-Density Residential District to "PUD" Planned Unit Development District classification for the Kum & Go Store #120 PUD District; and

WHEREAS, on August 24, 2015, by Roll Call No. 15-1433, the City Council received a communication from the City Plan and Zoning Commission advising that at a public hearing held on August 6, 2015, its members voted 11-0 in support of a motion to recommend APPROVAL of a request from Kum & Go, LC (owner), represented by Nick Halfhill (officer), for review and approval of the Second Amendment to the Kum & Go Store #120 PUD Conceptual Plan to allow an approved 6,321 square foot convenience store, with 16 fueling locations, to have a reconfigured site layout and a revised store and canopy design to fit the current corporate prototype, subject to revisions set forth in said communication from the Commission; and

WHEREAS, on August 24, 2015, by Roll Call No. 15-1433, it was duly resolved by the City Council that the request from Kum & Go, LC for approval of the Second Amendment to the Kum & Go Store #120 PUD Conceptual Plan for the Property as legally described below, be set down for hearing on September 14, 2015 at 5:00 P.M., in the Council Chamber at City Hall; and

WHEREAS, due notice of said hearing was published in the Des Moines Register, as provided by law, setting forth the time and place for hearing on said proposed amendment to the Kum & Go Store #120 PUD Conceptual Plan; and

WHEREAS, in accordance with said notice, those interested in said proposed amendment to the approved Kum & Go Store #120 PUD Conceptual Plan, both for and against, have been given opportunity to be heard with respect thereto and have presented their views to the City Council.

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, as follows:

1. Upon due consideration of the facts and any statements of interested persons and arguments of counsel, any and all objections to the proposed Second Amendment to the Kum & Go Store #120 PUD Conceptual Plan for the Property, locally known as 6304 Southwest 9th Street and legally described as follows, are hereby overruled, and the hearing is closed:

PARCEL "A" AS SHOWN ON THE PLAT OF SURVEY RECORDED IN BOOK 14052 AT PAGE 229 OF LOTS 1, 2, 21, & 22 IN LANGDON PLACE, AN OFFICIAL PLAT, NOW IN AND FORMING A PART OF THE CITY OF DES MOINES, POLK COUNTY, IOWA.
