SET HEARING FOR CONVEYANCE OF MULTIPLE CITY-OWNED PROPERTIES IN THE BIRDLAND PROJECT AREA TO HOME OPPORTUNITIES MADE EASY, INC. (HOME, INC.) FOR \$34,000

WHEREAS, on September 20, 1993, by Roll Call No. 93-3747, the City Council approved an emergency voluntary acquisition program to purchase residential properties severely damaged by the floods of 1993; and

WHEREAS, on October 25, 1993, by Roll Call No. 93-4031, the City Council established a voluntary acquisition program for flood-damaged owner-occupied residences, including an optional relocation benefits plan, by approving the program description titles Voluntary Acquisition Program of Residences (known as VAPOR); and

WHEREAS, on July 28, 2008, by Roll Call No. 08-1376, the City Council authorized to develop, execute, and administer an agreement with Neighborhood Finance Corporation to fund a voluntary flood acquisition program; approval to proceed with acquisition of eligible flood damaged properties in the Birdland Area; and authorization to allocate funds for the Home Restoration Program to be administered by the Polk County Housing Trust Fund to rehabilitate flood damaged properties in the Birdland Area (amended and extended on September 8, 2008 by Roll Call No. 08-1625); and

WHEREAS, the aforementioned voluntary buyouts left a number of vacant City-owned lots scattered throughout the Birdland Area; and

WHEREAS, on January 12, 2015, by Roll Call No. 15-0043, the City Council approved the Birdland Area Redevelopment Plan as an element of, and amendment to, the Des Moines' 2020 Community Character Land Use Plan, and authorized staff to initiate a request for proposal (RFP) process to dispose of select City-owned lot in the Birdland Area; and

WHEREAS, in accordance with said Council direction, the City Neighborhood Conservation Services Division of the Community Development Department distributed a Request for Proposal ("RFP") to developers certified with the City's Neighborhood Stabilization Program for the sale and redevelopment of the Properties; and

WHEREAS, Home Opportunities Made Easy, Inc. ("HOME, Inc.") responded to the RFP and was selected by the City staff reviewers as a recommended developer, and has offered to the City of Des Moines the purchase price of \$34,000, for fee simple interest in the properties listed below for the purpose of redevelopment, which price reflects the fair market land value of the properties as determined by the City's Real Estate Division; and

WHEREAS, there is no known current or future public need or benefit for the properties proposed to be sold, and the City will not be inconvenienced by the sale of the properties listed below, subject to the terms and conditions set forth herein.
