HOLD HEARING FOR VACATION AND CONVEYANCE OF A PORTION OF SOUTHWEST 31ST STREET AND WOLCOTT AVENUE RIGHT-OF-WAY ADJOINING 3029 WOLCOTT AVENUE TO GARY L. RANDA FOR \$150

WHEREAS, on November 5, 2015, the City Plan and Zoning Commission approved a request from Gary L. Randa for the vacation of a segment of the eastern portion of Southwest 31st Street right-of-way adjoining 3029 Wolcott Avenue, subject to the reservation of easements for all existing utilities in place until such time as they are abandoned or relocated, and the reservation of the right of entry for servicing the same; and

WHEREAS, on November 23, 2015, by Roll Call No. 15-1957, the City Council of the City of Des Moines, Iowa, received and filed said recommendation from the City Plan and Zoning Commission; and

WHEREAS, Gary L. Randa, owner of 3029 Wolcott Avenue, has offered to the City of Des Moines, Iowa, ("City") the purchase price of \$150.00 for the purchase of a portion of Southwest 31st Street right-of-way and a portion of Wolcott Avenue right-of-way for incorporation in to his residential property and in order to mitigate an existing fence encroachment, which price reflects the fair market value of said portion of vacated street right-of-way as currently estimated by the City's Real Estate Division; and

WHEREAS, there is no known current or future public need for the street right-of-way proposed to be vacated and the City will not be inconvenienced by the sale of said property; and


