APPROVING COMPLETION AND ACCEPTANCE OF THE PRIVATE CONSTRUCTION
CONTRACT FOR PAVING IMPROVEMENTS, E. 33RD STREET AND E. 34TH STREET,
BETWEEN MCANINCH CORPORATION AND ST. JOSEPH PARISH

WHEREAS, on July 14, 2014 under Roll Call No. 14-1036, the City Council approved a private construction contract in the amount of \$8,864.00, between McAninch Corporation, Douglas D. McAninch, President/COO, 4001 Delaware Avenue, Des Moines, IA, 50313 - as Contractor, and St. Joseph Parish, Fr. Ed Hurley, Pastor, 3300 Easton Boulevard, Des Moines, IA, 50317 - as Owner, for construction of Paving Improvements described as Construction of drop-off paving improvements in the east right-of-way of E. 33rd Street and a detention outlet structure in the west curb line of E. 34th Street at 3300 Easton Boulevard, in accordance with the contract documents including Plan File No. 540-095/096, and granted permission to the parties of said contract to construct these improvements in accordance with the contract documents and subject to the inspection and approval of the Des Moines City Engineer.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the attached report of the Des Moines City Engineer acknowledging the completion and recommending the acceptance of the construction of said Paving Improvements in the amount of \$8,864.00, which have been constructed in substantial compliance with the contract documents between McAninch Corporation and St. Joseph Parish, which were approved under Roll Call No. 14-1036, dated July 14, 2014, be received and filed; and that completion of said Paving Improvements described as Construction of drop-off paving improvements in the east right-of-way of E. 33rd Street and a detention outlet structure in the west curb line of E. 34th Street at 3300 Easton Boulevard, in accordance with the contract documents including Plan File No. 540-095/096, is hereby acknowledged and that said Paving Improvements are hereby accepted.






