APPROVING THE LEGAL DEPARTMENT'S RECOMMENDATION TO ADDRESS CERTAIN RISK MANAGEMENT ISSUES OCCASIONED BY THE LACK OF A FULL-TIME RISK MANAGER AND PRESSING DATA MANAGEMENT NEEDS, APPROVING AN EXCEPTION TO COMPETITIVE PROCUREMENT PROCESS, AND APPROVING LICENSE AGREEMENT WITH CYCOM DATA SYSTEMS, INC. TO PROVIDE SOFTWARE FOR LITIGATION MANAGEMENT SOFTWARE SERVICES

WHEREAS, upon the retirement of the Risk Manager in June 2013 some of the duties of that position devolved to the Finance Director and some were and remain non-assigned because of budget requirements; and

WHEREAS, a confidential litigation audit revealed that system administration was inefficient and insufficient for asset protection and claims processing as well as litigation case management; and

WHEREAS, the City of Des Moines Litigation Division has no digital means of tracking its docket of cases, preparing reports, establishing reserves and with the increased demand for risk management and audit data, manual searches of individual case files is neither efficient nor desirable; and

WHEREAS, in 2014, the City Attorney and Litigation Division attorneys and staff members worked with the IT Department to determine whether existing products used by the City would meet the City's needs with respect to certain and limited areas of asset protection and claims and litigation management satisfactory to the insurance industry without the need to procure additional software; and

WHEREAS, by 2015, working with such internal products was unsuccessful and thereafter, staff worked to investigate and review products on the market; and

WHEREAS, while other products exist for general litigation management in the private sector which devote much of the product to billing measures used in the private practice of law, Cycom Data Systems, Inc. ("Cycom"), P.O. Box 802, Richmond, KY 40476, possesses a litigation management product unique to the needs of a public agency with a combination of self-insured and insured cases; and

WHEREAS, Cycom's billing is tailored to the specific needs of the City, thereby making it the most reasonable of those products reviewed by staff and approved of by the City Attorney and City Manager; and

- 1) That good cause has been established to exempt the procurement of a litigation management product from the competitive procurement requirements of Des Moines Municipal Code Subsection 2-710(b); and
- 2) That a license agreement for CityLaw Case Management and Administrative Support System, a litigation management product installed, implemented and supported by Cycom Data Systems, Inc., Bob Jones, President, P.O. Box 802, Richmond, KY, 40476, is approved and the Mayor is authorized and directed to execute the License Agreement on behalf of the City of Des Moines; and
- 3) That the City Manager is authorized to negotiate, approve and execute subsequent annual support and maintenance fees as needed subject to review and approval of the Legal Department.
