- 4. The Mayor and City Clerk are hereby directed to execute and to certify the Municipal Housing Agency's budget for the fiscal year ending June 30, 2017 to the Des Moines City Council for incorporation into the City's fiscal year 2017 budget to be certified to the State of Iowa.
