APPROVAL OF CERTIFICATION TO THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT OF THE AMENDED OPERATING BUDGET FOR ALL PROJECTS FOR FISCAL YEAR ENDING JUNE 30, 2016 AND OF THE PROPOSED OPERATING BUDGET FOR ALL PROJECTS FOR FISCAL YEAR ENDING JUNE 30, 2017


WHEREAS, on February 8, 2016, by Roll Call Nos. 16-0169 and 16-1070, the Municipal Housing Governing Board set the public hearings to consider the Municipal Housing Agency's amended annual budget for all projects for the current fiscal year ending June 30, 2016 and to consider the Municipal Housing Agency's proposed budget for all projects for the fiscal year ending June 30, 2017, for February 22, 2016 and public notice of such hearings was published as provided by law in the Des Moines Register on February 10, 2016; and

WHEREAS, following the respective public hearings on February 22, 2016, the Municipal Housing Governing Board approved the Municipal Housing Agency's amendment to annual budget for all projects for the current fiscal year ending June 30, 2016, by Roll Call No. 16-0240 and approved the Municipal Housing Agency's proposed budget for all projects for the fiscal year ending June 30, 2017 by Roll Call No. 16-0241 ; and

WHEREAS, the Des Moines Municipal Housing Agency is required to certify approval of the operating budgets to the U.S. Department of Housing and Urban Development.

NOW, THEREFORE, BE IT RESOLVED by the Municipal Housing Governing Board that the Mayor and City Clerk are hereby authorized and directed to certify the Municipal Housing Agency's amended annual budget for all projects for the fiscal year ending June 30, 2016 and to certify the Municipal Housing Agency's proposed budget for all projects for the fiscal year ending June 30, 2017 on the forms on file in the Office of the City Clerk and the Acting Director of Housing Services is hereby directed to submit such certification to the U.S. Department of Housing and Urban Development.


