WHEREAS, in late 2011, the Capitol Park, Martin Luther King Jr. Park, and Capitol East neighborhoods were selected to participate in the City of Des Moines' Neighborhood Revitalization Program; and

WHEREAS, following two years of planning work, Viva East Bank! launched in August 2014 to make significant change in these three urban core neighborhoods; and

WHEREAS, Community Housing Initiatives, Inc. (CHI) has been a partner with the City of Des Moines in implementing the goals of Viva East Bank; and

WHEREAS, CHI provides a Project Manager to support the day-to-day activities, team meetings, and steering committee meetings for this project; and

WHEREAS, CHI is requesting reimbursement of administration funding in the amounts of \$40,000 for 2016 and \$25,000 for 2017 to assist with the costs of this Project Manager position.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the granting of \$40,000 in program year 2016 and \$25,000 in program year 2017 in Community Development Block Grant Administration funds to Community Housing Initiatives, Inc. (CHI) is hereby approved for the purposes stated above; that the Community Development Department Director and his designee(s) are authorized and directed to negotiate and administer a CDBG subrecipient contract with CHI for said funding; and the City Manager is authorized and directed to execute said contract on behalf of the City.
