HOLD HEARING FOR VACATION AND CONVEYANCE OF A PORTION OF CARLISLE ROAD RIGHT-OF-WAY TO THE POLK COUNTY CONSERVATION BOARD FOR \$1

WHEREAS, the Polk County Conservation Board is the owner of the real property locally identified as District/Parcel 050/04292-007-000, District/Parcel 050/04349-000-000 and District/Parcel 050/04339-005-000, which property adjoins and surrounds an undeveloped dead-end segment of Carlisle Road in Des Moines, Iowa; and

WHEREAS, the Polk County Conservation Board has requested the vacation and conveyance of said undeveloped dead-end segment of Carlisle Road right-of-way adjoining its property ("City Right-of-Way"), for no consideration in accordance with Iowa Code Section 364.7(3) for the public purposes of assembling said City Right-of-Way with its property in order to create a public park and recreation area, as consideration for acquisition of said City Right-of-Way, subject to a permanent easement upon, over and within the City Right-of-way for the continued use and maintenance of and the right of access to any existing utilities and flood protection levee improvements now in place; and

WHEREAS, the City Right-of-Way proposed to be vacated and conveyed has been determined by the City Engineer and City Traffic Engineer to have no significant impact on public access; there is no known current or future public need or benefit for the City Right-of-Way proposed to be vacated and conveyed and the City will not be inconvenienced by the vacation and conveyance of said City Right-of-Way; and

WHEREAS, on March 21, 2016, by Roll Call No. 16-0463, it was duly resolved by the City Council of the City of Des Moines, Iowa, that the proposed vacation and conveyance of the City Right-of-Way be set down for hearing on April 11, 2016, at 5:00 p.m., in the City Council Chambers; and

WHEREAS, due notice of said proposal to vacate and convey the City Right-of-Way was given as provided by law, setting forth the time and place for hearing on said proposal; and

WHEREAS, in accordance with City Council direction, those interested in the proposed vacation and conveyance, both for and against, have been given an opportunity to be heard with respect thereto and have presented their views to the City Council of the City of Des Moines, Iowa.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, as follows:

1. Upon due consideration of the facts and statements of interested persons, any and all objections to the proposed vacation and conveyance of the City Right-of-Way, as described herein, are hereby overruled and the hearing is closed.

2. There is no public need or benefit for the City Right-of-Way proposed to be vacated, and the public would not be inconvenienced by reason of the vacation of a portion of Carlisle Road right-of-way adjoining District/Parcel 050/04292-007-000, District/Parcel 050/04349-000-000 and District/Parcel 050/04339-005-000, as legally described below, and said vacation is hereby approved:

- 7. Upon receipt of the recorded documents back from the Polk County Recorder, the Real Estate Division Manager shall mail the original of the Quit Claim Deed and copies of the other documents to the grantees.
- 8. There will be no proceeds associated with the conveyance of this property.


