SET HEARING FOR VACATION AND CONVEYANCE OF THE NORTH/SOUTH ALLEY RIGHT-OF-WAY LOCATED NORTH OF CROCKER STREET BETWEEN 8TH STREET AND 9TH STREET TO HRC 8th STREET, LLC FOR \$31,350.00

WHEREAS, on April 7, 2016, the City Plan and Zoning Commission voted to recommend to the City Council of the City of Des Moines, Iowa that a dead-end segment of north/south alley right-of-way located west of and adjoining 900 and 922 8th Street, and hereinafter more fully described, be vacated, subject to reservation of easements for all existing utilities in place, until such time that they are abandoned or relocated; and

WHEREAS, HRC 8th Street, LLC is currently under contract to purchase 900 8th Street and 922 8th Street, and has offered to the City of Des Moines, Iowa ("City") the purchase price of \$31,350.00 for the purchase of the portion of the alley right-of-way lying west of and adjoining 900 8th Street and 922 8th Street for incorporation into the adjoining commercial property to allow for redevelopment, which price reflects the fair market value of said portion of alley right-of-way as currently estimated by the City's Real Estate Division; and

WHEREAS, said conveyance is contingent upon HRC 8th Street, LLC or an affiliate obtaining title to both 900 8th Street and 922 8th Street; and


WHEREAS, there is no known current or future public need for the alley right-of-way proposed to be vacated and sold, and the City will not be inconvenienced by the vacation and sale of said property.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that:

1. That the City Council of the City of Des Moines, Iowa, shall consider adoption of an ordinance permanently vacating a portion of north/south alley right-of-way located west of and adjoining 900 and 922 8th Street, legally described as follows:

-EXCEPT THE NORTH 33.5 FEET-, ALL OF THE NORTH/SOUTH 16 FOOT ALLEY LYING EAST OF AND ADJOINING LOTS 1, 2, 3 AND 4 IN THE SUBDIVISION OF BLOCK P IN HOLCOMB'S ADDITION TO FORT DES MOINES, AN OFFICIAL PLAT, ALL NOW INCLUDED IN AND FORMING A PART OF THE CITY OF DES MOINES, POLK COUNTY, IOWA, AND CONTAINING APPROXIMATELY 3688 SQUARE FEET.

2. The City Council of the City of Des Moines, Iowa, further proposes to sell the portion of north/south alley right-of-way located west of and adjoining 900 and 922 8th Street, as legally described and to the grantees and for the consideration identified below, subject to reservation of easements therein:
