This project will include scarification/pavement removal, full depth patching, furnish and place HMA, pavement markings, and miscellaneous associated work including cleanup; in accordance with the contract documents, including Plan File Nos. 572-101/110, 56th Street from Grand Avenue to Ingersoll Avenue, Des Moines, Iowa


