APPROVING PAYMENT OF BILLING FROM HALL & ASSOCIATES FOR REPRESENTATION IN THE MATTER ENTITLED IOWA LEAGUE OF CITIES V. UNITED STATES ENVIRONMENTAL PROTECTION AGENCY

WHEREAS, on August 23, 2010, by Roll Call No. 10-1373, the City Council authorized the retention of Hall & Associates for representation in the action entitled Iowa League of Cities v. United States Environmental Protection Agency in an amount not to exceed \$25,000.00, and authorized the City Attorney to sign a joint Litigation Agreement, an engagement letter and or other agreement as necessary to secure such joint representation; and

WHEREAS, on May 20, 2013, by Roll Call No. 13-0801, the City Council authorized an additional amount of not to exceed \$1,500.00, and directed the City Attorney to sign an amendment to the Joint Litigation Agreement or other agreement, if necessary, for the additional authorization with Hall & Association; and

WHEREAS, on December 23, 2013, by Roll Call No. 13-1967, the City Council authorized an additional amount of not to exceed \$1,500.00, and directed the City Attorney to sign an amendment to the Joint Litigation Agreement or other agreement, if necessary, for the additional authorization with Hall & Association; and

WHEREAS, on July 14, 2014, by Roll Call No. 14-1059, the City Council authorized an additional amount of not to exceed \$1,500.00; and

WHEREAS, on October 20, 2014, by Roll Call No. 14-1633, the City Council authorized an additional amount of not to exceed \$2,500.00; and

WHEREAS, Hall & Associates has submitted a billing dated April 29, 2016 in the total amount of \$2,297.15 with the City's portion being \$229.71; and

WHEREAS, the City Legal Department has reviewed said billing and verified it to be correct and recommends payment.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the billing be forwarded to the Finance Department, and that the Finance Director be and is hereby authorized and directed to issue a check in the amount of \$229.71 to Hall & Associates.
