APPROVAL OF USE AGREEMENT WITH IOWA WORKFORCE DEVELOPMENT FOR PARKING FOR BRENTON SKATING PLAZA PATRONS AT 150 DES MOINES STREET

WHEREAS, Iowa Workforce Development possesses authority and control over a parking lot located at 150 Des Moines Street, Des Moines, Iowa ("Parking Lot"); and

WHEREAS, the City of Des Moines, Iowa ("City") provides support for the Brenton Skating Plaza, located at 520 Robert D. Ray Drive, Des Moines, Iowa, including parking for its patrons; and

WHEREAS, due to upcoming construction activities in the area, there will not be adequate parking to accommodate all the Brenton Skating Plaza patrons; and

WHEREAS, the City desires to use the Parking Lot for parking by Brenton Skating patrons; and

WHEREAS, as a gesture of good will to the community, Iowa Workforce Development desires to allow use of the Parking Lot for parking by Brenton Skating Plaza patrons during times that the Parking Lot is not required for Iowa Workforce Development's business operations.

WHEREAS, a copy of the proposed Use Agreement is on file in the office of the City Clerk.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa:

1. That the Use Agreement for Parking for Brenton Skating Plaza Patrons on file in the office of the City Clerk allowing use of the parking lot owned by Iowa Workforce Development located at 150 Des Moines Street is hereby approved.
2. That the City Manager is authorized and directed to sign the Use Agreement for Parking for Brenton Skating Plaza Patrons and related documents as approved by the Legal Department on behalf of the City.
3. That no payment is associated with this Use Agreement for Parking for Brenton Skating Plaza Patrons.
