## RESOLUTION CONINUING DATE OF PUBLIC HEARING ON PETITION TO ESTABLISH THE SW 9<sup>TH</sup> CORRIDOR SELF-SUPPORTED MUNICIPAL IMPROVEMENT DISTRICT AND SETTING NEW HEARING DATE.

WHEREAS, on February 22, 2016, by Roll Call No. 16-0303, the City Council received a petition to establish the SW 9<sup>th</sup> Corridor Self-Supported Municipal Improvement District, and referred the Petition to the City Plan and Zoning Commission for preparation of an evaluative report for the Council on the merit and feasibility of the proposed project and improvements as required by Iowa Code Chapter 386; and,

WHEREAS, the City Plan and Zoning Commission has submitted its report and recommendation on the merit and feasibility of the proposed SW 9<sup>th</sup> Corridor Self-Supported Municipal Improvement District, and,

WHEREAS, Iowa Code Chapter 386 provides that upon receipt of the final report of the Plan and Zoning Commission the Council shall set a time and place for a hearing upon the Petition and shall cause proper notice to be given.

WHEREAS, a hearing date was previously set for May 23, 2016 in Roll Call No. 16-0670; a new hearing date needs to be set to provide additional notice as required by Iowa Code section 386.3(4).

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, as follows:

- 1. That the hearing previously set for May 23, 2016 is continued until June 13, 2016.
- 2. That the City Council consider the Petition to Establish the SW 9<sup>th</sup> Corridor Self-Supported Municipal Improvement District at a public hearing to be held on June 13, 2016, at 5:00 p.m., in the Council Chambers at which time the City Council will hear both those who oppose and those who favor the proposal.
- 3. That notice of said proposal shall also be given by certified mail not less than 15 days before the hearing to each property owner within the proposed district at the owner's address as shown by the records of the County Auditor, all as required by Iowa Code section 386.3(4).


