APPROVING AMENDMENT NO. 2 TO COOPERATIVE AGREEMENT WITH IOWA DEPARTMENT OF NATURAL RESOURCES (IDNR) TO FUND EASTER LAKE WATERSHED QUALITY IMPROVEMENT PROJECT

WHEREAS, on February 27, 2012, by Roll Call No. 12-0358, the City Council approved a 28E Cooperative Agreement with the Iowa Department of Natural Resources (IDNR) and Polk County Conservation Board to develop a Water Quality Plan for Easter Lake to address impairments caused by excess nutrients and sediment delivery to Easter Lake; and

WHEREAS, on August 11, 2014, by Roll Call No. 14-1257, the City Council approved a Cooperative Agreement with the IDNR for the Easter Lake Water Quality Management Plan, in which the IDNR agreed to reimburse the City up to \$500,000 or 50% of the costs of a project for stream stabilization within Yeader Creek and urban conservation practices within Ewing Park in conformance with the Water Quality Plan ("Cooperative Agreement"); and

WHEREAS, on October 26, 2015, by Roll Call No. 15-1764, the City Council approved Amendment No. 1 to the Cooperative Agreement, which increased IDNR funding by \$23,000; and

WHEREAS, the IDNR has proposed an Amendment No. 2 to the Cooperative Agreement by which IDNR will increase its funding amount by \$306,000 to a new total of \$829,000 for such project and extend the ending date to June 30, 2017, with the City's matching amount up to \$829,000, a copy of which is on file in the City Clerk's Office.
