## RESOLUTION AUTHORIZING AND APPROVING RELEASE OF PERPETUAL PUBLIC INGRESS AND EGRESS EASEMENT RESERVATION OVER A PORTION OF VACATED ALLEY RIGHT-OF-WAY FOR THE PROPERTY AT 927 8<sup>TH</sup> STREET

**WHEREAS**, on February 12, 2001, by Roll Call No. 01-442, the City Council of the City of Des Moines, Iowa, approved the vacation and conveyance of the north/south alley right-of-way in the block bounded by 7<sup>th</sup>, 8<sup>th</sup>, School and Crocker Streets (City Right-of-Way) to Dynasty Properties, L.L.C., 941 8<sup>th</sup> Street, for \$12,700.00; to Beckley Properties, L.L.C., 901 8<sup>th</sup> Street, for \$3,700.00; and to Hosier, Inc., 927 8<sup>th</sup> Street, for \$4,600.00; and

WHEREAS, on February 12, 2001, the City of Des Moines, Iowa, executed a Quit Claim Deed conveying the City Right-of-Way to Hosier, Inc.; said Quit Claim Deed being subsequently recorded in the office of the Recorder of Polk County, Iowa, on April 26, 2001 in Book 8791, Page 995, and containing the reservation by City of a perpetual public ingress and egress easement for pedestrian and vehicular access purposes; and

WHEREAS, on April 11, 2016, by Roll Call No. 16-0556, the City Council of the City of Des Moines, Iowa approved the Release of Perpetual Public Ingress and Egress Easement from that portion of the Property legally described as follows:

The West ½ of the vacated North/South alley right-of-way lying East of and adjoining Lots 14 and 15, George Sneer's Subdivision of Division 4 of Grimmel's Addition, an Official Plat, all now included in and forming a part of the City of Des Moines, Polk County, Iowa.

WHEREAS, Hubbell Realty Company, as current owner of the Property, has paid the City one thousand dollars (\$1,000.00) for the release of said Perpetual Public Ingress and Egress Easement; and

WHEREAS, a portion of the City Right-of-Way adjoining 927 8<sup>th</sup> Street, as described below, was mistakenly excluded from the legal description of the Release of Perpetual Public Ingress and Egress Easement that was approved by the City Council of the City of Des Moines, Iowa on April 11, 2016, by Roll Call No. 16-0556 and filed for record on May 20, 2016, in Book 16010, Page 196 in the office of the Polk County Recorder.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that:

1. There is no public need for the property interest described below and the public would not be inconvenienced by reason of the release of the City's perpetual public ingress and egress easement reservation over the remaining portion of property specifically described as follows:
