RESOLUTION FIXING DATE FOR A MEETING ON THE PROPOSITION OF THE ISSUANCE OF NOT TO EXCEED \$9,400,000 OF STORMWATER MANAGEMENT UTILITY REVENUE BONDS SERIES 2016C AND PROVIDING FOR PUBLICATION OF NOTICE THEREOF

WHEREAS, the City of Des Moines, Iowa is in need of funds to carry out certain storm water drainage construction projects as hereinafter described; and, it is deemed necessary that it should issue Stormwater Management Utility Revenue Bonds to the amount of not to exceed \$9,400,000 as authorized by Section 384.84A of the City Code of Iowa, for the purpose of providing funds to pay costs thereof; and

WHEREAS, before said Bonds may be issued, it is necessary to comply with the provisions of Section 384.84A of the City Code of Iowa, and to publish a notice of the proposal to issue such Bonds and the right to petition for an election thereon.

King Jr. Pkwy., Des Moines, Iowa, at 5:00 o'clock P.M., on the 22nd day of August, 2016, for the purpose of taking action on the matter of the issuance of not to exceed \$9,400,000 of Stormwater Management Utility Revenue Bonds, Series 2016C, to evidence the obligations of the City thereunder. Said Bonds will not constitute general obligations or be payable in any manner by taxation, but will be payable from and secured by the net revenues of the Des Moines Stormwater Management Utility. Proceeds of the Bonds will be used to provide funds to pay costs of refunding and refinancing of the Stormwater Management Utility Revenue Bonds, Series 2006D, dated December 19, 2006. The Bonds shall bear interest at a rate not exceeding the maximum specified in the attached notice.

Section 2. That the Clerk is hereby directed to cause at least one publication to be made of a notice of said meeting in a legal newspaper, printed wholly in the English language, published at least once weekly, and having general circulation in said City, said publication to be not less than thirty (30) clear days before the date of said public meeting on the issuance of said Bonds.

At any time before the date of said meeting, a petition asking that the question of issuing such Bonds be submitted to the legal voters of said City may be filed with the Clerk of said City, pursuant to the provisions of Section 384.84A of the City Code of Iowa.
