APPROVE COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) FUNDING ALLOCATIONS FOR 2015 AND 2016, RECEIVE CITY MANAGER RECOMMENDATION FOR FUTURE ALLOCATIONS, AND AUTHORIZE THE CITY MANAGER TO EXECUTE AN AGREEMENT WITH IMPACT COMMUNITY ACTION PARTNERSHIP

WHEREAS, on May 18, 2015, by Roll Call No. 15-871, the City Council approved the Assumption Agreement by and between the City of Des Moines and the Red Rock Area Community Action Program, now known as Impact Community Action Partnership, for the conveyance of the Des Moines Community Action Agency programs and service area; and

WHEREAS, Impact Community Action Partnership provides critical support programs and guidance for people in need, specifically for home energy and weatherization assistance, food support, and personal finance education; and

WHEREAS, Section 9 of the Assumption Agreement provides that the City may grant Community Development Block Grant (CDBG) funds to Impact Community Action Partnership to assist in the delivery of community action agency services and programs, such as operational costs for an emergency youth shelter which are eligible expenses for the CDBG program, subject to annual approval by the City Council and execution of and compliance with CDBG sub-recipient grant agreements; and

WHEREAS, the City Manager recommends that a portion of the City’s CDBG funding be allocated to Impact Community Action Partnership accordingly:

- 2015 - \$66,624.87 (remaining funding as a City operation)
- 2016 - \$200,000
- 2017 - \$150,000
- 2018 - \$100,000
- 2019 until terminated or amended - \$50,000

NOW, THEREFORE BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the proposed CDBG funding allocations for 2015 and 2016 listed above to Impact Community Action Partnership are hereby approved, and the City Manager’s recommendation for funding allocations for future years is hereby received and filed.

BE IT FURTHER RESOLVED by the City Council of the City of Des Moines, Iowa, that the City Manager is hereby authorized to execute a sub-recipient grant agreement with Impact Community Action Partnership for payment and administration of the 2015 and 2016 CDBG funding allocations, subject to review and approval as to form by the Legal Department.
