## RESOLUTION APPROVING ISSUANCE OF CERTIFICATE OF COMPLETION TO ARTISAN ROW, LLC, FOR THE ARTISAN ROW PROJECT IN THE 1700 BLOCK OF GRAND AVENUE

WHEREAS, on April 21, 2014, by Roll Call No. 14-0627, the City Council approved an Urban Renewal Development Agreement (the "Agreement") with Artisan Row, LLC, represented by Rick Tollakson, Manager, whereby Artisan Row agreed to undertake the renovation and redevelopment of the block bounded by Grand and Ingersoll Avenues and 16th and 17th Streets, by undergrounding the overhead utility lines; the construction of 27 townhomes having either 3 bedrooms or 2 master bedrooms, and having 3 baths, attached two-car garages, and rooftop patios with pergolas, and approximately 1,350 square feet of finished space; and, the construction of offstreet parking, landscaping and streetscape improvements and common area amenities, all in conformance with the approved Conceptual Development Plan and hereinafter collectively referred to as the "Improvements"; and,

WHEREAS, on December 21, 2015, by Roll Call No. 15-2126, the City Council approved the First Amendment to Urban Renewal Agreement with Artisan Row, LLC, which amended the Agreement to reduce the number of dwelling units to 26 in recognition that two of the units were combined to create a larger unit, and to delay the deadline for completion to May 31, 2016; and,

WHEREAS, the Improvements have been completed in substantial compliance with the Development Agreement and the approved Conceptual Development Plan; and,

WHEREAS, Artisan Row, LLC, has requested the City issue a Certificate of Completion as evidence of Artisan Row's satisfaction of its construction obligations under the Development Agreement.

**NOW THEREFORE, BE IT RESOLVED,** by the City Council of the City of Des Moines, Iowa, as follows:

1. The City Council hereby finds and acknowledges that Artisan Row, LLC, has satisfied its obligation to complete the Improvements to the block bounded by Grand and Ingersoll Avenues and 16th and 17th Streets and more specifically described as follows, in substantial compliance with the Development Agreement and the approved Conceptual Plan. This resolution shall serve as the Certificate of Completion to be issued by the City pursuant to Section 2.4 of the Development Agreement.
