RESOLUTION ALLOCATING CERTAIN PARK AND RIDE FUNDS TO DART FOR ESTABLISHMENT OF START-UP SATURDAY D-LINE SERVICE AND OTHER TRANSPORTATION PURPOSES

WHEREAS, on January 27, 2014, the City of Des Moines entered into an Agreement with the Des Moines Area Regional Transportation Authority ("DART") and under the review and purview of the Federal Transportation Authority, which Agreement provided, in pertinent part, that the City would periodically allocate certain funds for transportation purposes recognized under Federal law; and

WHEREAS, pursuant to said Agreement, the City Manager has identified such recognized transportation purposes, including without limitation the partial funding of the "D-Line" service currently running as well as the establishment of Saturday "D-Line" services and other federally recognized transportation purposes and recommends funding such transportation purposes in the amount of \$315,000 per year in Fiscal Years 2017 and 2018, as set forth herein; and

WHEREAS, the City Council agrees with such allocation for the Fiscal Years 2017 and 2018, so long as DART continues to operate the "D-Line" as currently operated and includes Saturday "D-Line" services and utilizes any remaining funds as directed by the City Manager.

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, as follows:

That there is hereby allocated the sum of \$315,000 per year from the Park and Ride funds of the City for Fiscal Years 2017 and 2018 to satisfy the requirements of the January 27, 2014 Agreement; provided that such allocation shall be utilized as specified herein and shall be provided to DART only for the purposes elucidated by the City Manager.
