PUBLIC HEARING, APPROVING PLANS, SPECIFICATIONS, FORM OF CONTRACT DOCUMENTS, AND ENGINEER'S ESTIMATE ON MUNICIPAL BUILDINGS REROOFING - CONTRACT 1; RECEIVE AND FILE BIDS; AND DESIGNATION OF LOWEST RESPONSIVE, RESPONSIBLE BIDDER AS BROCKWAY MECHANICAL & ROOFING COMPANY, INC., RYAN M. BROCKWAY, VICE PRESIDENT, \$252,200.00

WHEREAS, on July 11, 2016, under Roll Call No. 16-1099, plans, specifications, form of contract documents, and Engineer's estimate of construction cost were filed with the City Clerk, for the construction of the following improvement:

Municipal Buildings Reroofing - Contract 1, 10-2016-007

The improvement includes the complete removal of the existing roofing materials and installation of a fully adhered white EPDM (ethylene propylene diene terpolymer) roof on two municipal buildings; all work in accordance with the contract documents including Plan File Nos. 574-001/004, located at Parks Warehouse, 1300 Scott Avenue and Public Works Out Building, 216 S.E. 5th Street, all in Des Moines, Iowa

WHEREAS, notice of the hearing on the plans, specifications, form of contract documents, and Engineer's estimate of construction cost was published as required by law.

BE IT FURTHER RESOLVED: That the Des Moines City Engineer, as the Engineer, has determined that the lowest responsive, responsible bid for the construction of said improvement was submitted by Brockway Mechanical & Roofing Company, Inc., Ryan M. Brockway, Vice President, 1025 Osborn Street, Burlington, IA, 52601 in the amount of \$252,200.00, and said bid be and the same is hereby accepted.
