RESOLUTION REPEALING ORDINANCE NO. 10,836 AND REDEDICATING PORTIONS OF THE SIDEWALK AREAS ON BOTH SIDES OF WALNUT STREET WITHIN THE FORMER WALNUT STREET TRANSIT MALL BETWEEN 5^{TH} AVENUE AND 10^{TH} STREET AS PUBLIC RIGHT-OF-WAY

WHEREAS, on June 23, 1986, by Roll Call No. 96-2993 the City Council of the City of Des Moines, Iowa passed Ordinance No. 10,836 vacating portions of the sidewalk areas on both sides of Walnut Street within the Walnut street Transit Mall between 5th Avenue on the east and 10th Street on the west; and

WHEREAS, the Walnut Street Transit Mall operations have been removed along Walnut Street and the area is being reestablished for use with typical street right-of-way purposes; and

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa:

1. Ordinance No. 10,836 is hereby repealed and the portions of Walnut Street right-of-way described below are hereby rededicated as public right-of-way for Walnut Street:

Portions of the sidewalk areas on both sides of Walnut Street within the former Walnut Street Transit Mall between 5th Avenue on the east and 10th Street on the west, the exact location of the areas to be rededicated being shown as the blue colored sidewalk areas extending from the curb line backward on both sides of Walnut Street on the attached maps.

- 2. The City Clerk is hereby authorized and directed to forward the original of this resolution to the Real Estate Division of the Engineering Department for the purpose of causing said documents to be recorded.
- 3. The Real Estate Division Manager is authorized and directed to forward the original of this Resolution, together with a certified copy of this resolution and all corresponding maps to the Polk County Recorder's Office for the purpose of causing these documents to be recorded.
