**APPROVING AN EXCEPTION TO THE PROCUREMENT ORDINANCE
COMPETITIVE RFP PROCESS FOR GOOD CAUSE AND ACCEPTING PROPOSAL
OF ANN APPLESETH COMMUNICATIONS, LLC TO PROVIDE STRATEGIC
COMMUNICATION PLAN CONSULTING SERVICES AND AUTHORIZING CITY
MANAGER TO EXECUTE CONTRACT FOR THE PROVISION OF SAME**

WHEREAS, creation and implementation of a strategic communications plan is a 2016 Strategic Plan Top Priority of the City Manager; and

WHEREAS, the City Manager has determined that Ann Appleseth Communications, LLC has the best ability to develop such plan due to their team's unmatched experience in public relations, marketing, communications and strategic planning; and

WHEREAS, the City Manager recommends that the procurement of such consulting services be exempted from the competitive Request for Proposals process for good cause shown, pursuant to Section 2-710(b) of the Municipal Code of the City of Des Moines, based upon the extensive experience of Ann Appleseth Communications, LLC; and

WHEREAS, Ann Appleseth Communications, LLC has submitted a proposal to provide such services in the amount of not to exceed \$50,000.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that good cause has been shown to exempt the procurement of strategic communication plan consulting services from the Procurement Ordinance competitive Request for Proposal process.

BE IT FURTHER RESOLVED that the proposal submitted by Ann Appleseth Communications, LLC is hereby accepted and the City Manager is authorized and directed to negotiate and execute an agreement with Ann Appleseth Communications, LLC to provide consulting services as described above for and on behalf of the City of Des Moines, subject to approval as to form by the Legal Department, and the City Clerk is authorized to attest to his signature.
