APPROVING COMPLETION AND ACCEPTANCE OF THE PRIVATE CONSTRUCTION
CONTRACT FOR STORM SEWER IMPROVEMENTS, BLOOMFIELD ACRES PLAT 1,
BETWEEN LITTLE KADING CONSTRUCTION COMPANY, INC. AND BLOOMFIELD ACRES L.L.C.

WHEREAS, on August 24, 2015 under Roll Call No. 15-1415, the City Council approved a private construction contract in the amount of \$189,222.00, between Little Kading Construction Company, Inc., Rick Kading, Owner, 7008 Madison Avenue, Urbandale, IA, 50322 - as Contractor, and Bloomfield Acres L.L.C., Karie Ramsey, General Manager, P.O. Box 1247, Johnston, IA, 50131 - as Owner, for construction of Storm Sewer Improvements described as storm sewer construction to serve Bloomfield Acres Plat 1 proposed subdivision, located on the north side of Bloomfield Road at 1916 Bloomfield Road, Des Moines, Iowa, all work as per Plan File Nos. 570-013/027, and granted permission to the parties of said contract to construct these improvements in accordance with the contract documents and subject to the inspection and approval of the Des Moines City Engineer.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the attached report of the Des Moines City Engineer acknowledging the completion and recommending the acceptance of the construction of said Storm Sewer Improvements in the amount of \$189,222.00, which have been constructed in substantial compliance with the contract documents between Little Kading Construction Company, Inc. and Bloomfield Acres L.L.C., which were approved under Roll Call No. 15-1415, dated August 24, 2015, be received and filed; and that completion of said Storm Sewer Improvements described as storm sewer construction to serve Bloomfield Acres Plat 1 proposed subdivision, located on the north side of Bloomfield Road at 1916 Bloomfield Road, Des Moines, Iowa, all work as per Plan File Nos. 570-013/027, is hereby acknowledged and that said Storm Sewer Improvements are hereby accepted.
