APPROVING COMPLETION AND ACCEPTANCE OF THE PRIVATE CONSTRUCTION CONTRACT FOR PAVING IMPROVEMENTS, BLOOMFIELD ACRES PLAT 1, BETWEEN STERNOUIST CONSTRUCTION INC. AND BLOOMFIELD ACRES L.L.C.

WHEREAS, on August 24, 2015 under Roll Call No. 15-1414, the City Council approved a private construction contract in the amount of \$271,537.50, between Sternquist Construction Inc., Britt Sternquist, President, 1110 N 14th Street, Indianola, IA, 50125 - as Contractor, and Bloomfield Acres L.L.C., Karie Ramsey, General Manager, P.O. Box 1247, Johnston, IA, 50131 - as Owner, for construction of Paving Improvements described as construction of PCC paving improvements in the proposed Bloomfield Acres Plat 1 on the north side of Bloomfield Road at 1916 Bloomfield Road, as per Plan File Nos. 570-013/027, and granted permission to the parties of said contract to construct these improvements in accordance with the contract documents and subject to the inspection and approval of the Des Moines City Engineer.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the attached report of the Des Moines City Engineer acknowledging the completion and recommending the acceptance of the construction of said Paving Improvements in the amount of \$271,537.50, which have been constructed in substantial compliance with the contract documents between Sternquist Construction Inc. and Bloomfield Acres L.L.C., which were approved under Roll Call No. 15-1414, dated August 24, 2015, be received and filed; and that completion of said Paving Improvements described as construction of PCC paving improvements in the proposed Bloomfield Acres Plat 1 on the north side of Bloomfield Road at 1916 Bloomfield Road, as per Plan File Nos. 570-013/027, is hereby acknowledged and that said Paving Improvements are hereby accepted.
