RESOLUTION ACKNOWLEDGING ASSIGNMENT OF URBAN RENEWAL DEVELOPMENT AGREEMENT AND ECONOMIC DEVELOPMENT GRANT PAYMENTS (LIBERTY BUILDING REHABILITATION AND PARKING GARAGE DEVELOPMENT)

WHEREAS, on April 6, 2005, by Roll Call No. 05-814, the City Council of the City of Des Moines approved an Urban Renewal Development Agreement ("Development Agreement") with Liberty Building Development Group, L.L.C., f/k/a K.C. Holdings VI, L.L.C. ("Liberty") for the rehabilitation of the Liberty Building located at 418 Sixth Avenue and for the construction of a parking garage at 518 Grand Avenue; and

WHEREAS, on April 12, 2010, by Roll Call No. 10-558, the City Council approved a First Amendment to Development Agreement wherein Liberty undertook hotel renovation improvements within the Liberty Building which Amendment authorized a Reduced Economic Development Grant and an Additional Economic Development Grant tied to the hotel renovation improvements, each to be paid in installments; and

WHEREAS, on August 27, 2012, by Roll Call No. 12-1389, the City Council approved an Assignment of the Additional Economic Development Grant installments from Liberty to 418 Hospitality, L.L.C.; and

WHEREAS, on March 11, 2013, by Roll Call No. 13-0408, the City Council approved the Second Amendment to Development Agreement wherein the City permitted urban revitalization tax abatement on the hotel renovation improvements and made a commensurate reduction to the Additional Economic Development Grant; and

WHEREAS, on February 9, 2015, by Roll Call No. 15-0208, the City Council approved an assignment of the Reduced Economic Development Grant installments from Liberty to Liberty Building Historic Rehab, L.L.C.; and

WHEREAS, Liberty Building Historic Rehab, L.L.C. and 418 Hospitality, L.L.C. desire to sell their interests in the properties to Liberty Des Moines, L.L.C. and have submitted an Assignment and Assumption Agreement wherein all interests in the Development Agreement and the future installment of the Reduced Economic Development Grant and Additional Economic Development Grant installments will be assigned to and assumed by Liberty Des Moines, L.L.C.; and

WHEREAS, the parties to the Assignment and Assumption Agreement have requested the City's acknowledgment and consent to the document.
