RESOLUTION ESTABLISHING REVISED FAIR MARKET VALUE OF PROPERTY OWNED BY RSC PARTNERS, LLC AT 900 42ND STREET FOR THE 42ND STREET STREETScape PROJECT

WHEREAS, on March 21, 2016, by Roll Call No. 16-0449, the City Council of the City of Des Moines, Iowa authorized the acquisition, by gift, negotiation, or eminent domain, of the right-of-way and easements required for the 42nd Street Streetscape Project; and

WHEREAS, on June 13, 2016, by Roll Call No. 16-0936, the City Council of the City of Des Moines, Iowa established fair market value of various properties for this project, including property located at 900 42nd Street in Des Moines, which property is owned by RSC Partners, LLC; and

WHEREAS, said property has been appraised by an independent appraisal firm, and because of design changes to the project requested by the property owner, the appraisal was revised; and

WHEREAS, based upon the revised appraisal, the suggested fair market value of the property interests to be acquired are as follows:

Titleholder:	RSC Partners, LLC
Property Location:	900 42 nd Street, Des Moines, IA 50312
Property Interest to Be Acquired:	Permanent Easement for Utility Corridor and Permanent Easement for Traffic Signal and Street Lighting Systems
Fair Market Value:	\$17,313 (plus closing costs)

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa:

That the valuation listed and identified above as "Suggested Fair Market Value" is hereby established as the fair market value of the property interests listed herein.

That the Real Estate Division of the Engineering Department is authorized and directed to acquire the property interests through gift, negotiation or condemnation based upon the approved fair market value listed above.

That the property interests will be acquired in accordance with the guidelines of 49 CFR Part 24 of the Uniform Relocation and Real Property Acquisition Act, as revised, and that relocation is hereby authorized.

If the property owner agrees to convey the property interests to the City in an amount based on the established fair market value, including an approved administrative settlement, or if a condemnation award is based on the established fair market value or falls within an approved settlement amount, the Finance Director is authorized and directed to issue checks in the amounts necessary to carry out these

transactions and to pay any unforeseen additional costs certified by the Legal Department and the Engineering Department; the Real Estate Division Manager is authorized and directed to complete these transactions in accordance with standard real estate practices and state law requirements.

That the Real Estate Division of the Engineering Department is directed to obtain the Legal Department's review and approval of all closing documents prior to closing.

That the City Clerk is hereby authorized and directed to endorse upon the real estate documents listed above the approval and acceptance of this Council, the Mayor is authorized and directed to sign all necessary real estate documents, and the City Clerk is further authorized and directed to deliver the aforementioned documents to the Real Estate Division Manager, who shall proceed to closing in accordance with standard real estate practices.
