**CONSENT TO ASSIGNMENT AND APPROVAL OF EXTENSION TO
CONTRACT WITH ADVANCED DATA PROCESSING, INC. A SUBSIDIARY OF
INTERMEDIIX CORPORATION FOR EMERGENCY MEDICAL
AMBULANCE BILLING AND COLLECTION SERVICES**

WHEREAS, by Roll Call No. 09-2235 of December 7, 2009, the City Council of the City of Des Moines, Iowa accepted a proposal from Intermedix Corporation and authorized execution of a contract for emergency medical ambulance billing and collection services ("Contract") with an initial three-year term; and

WHEREAS, the City has subsequently exercised its options to extend the term of the Contract for three additional one-year periods ending December 31, 2015 and by Roll Call No. 15-2134 of December 21, 2015 and Roll Call No. 16-0689 of April 25, 2016 further extended the term of the Contract to September 30, 2016; and

WHEREAS, the City staff will further continue the process of soliciting proposals for emergency medical ambulance billing and collection services pursuant to a new request for proposals; and

WHEREAS, Intermedix Corporation has requested that the City consent to the assignment of its interests in the Contract to its subsidiary company Advanced Data Processing, Inc.; and

WHEREAS, in order to provide adequate additional time to complete the new request for proposals selection process and make a recommendation to the City Council on the selection of a preferred Contractor, it is necessary to extend the Contract with Advanced Data Processing, Inc. for an additional nine months to June 30, 2017.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City Of Des Moines, Iowa that Consent to Assignment of Contract to Advanced Data Processing, Inc., on file in the Office of the City Clerk is hereby approved and the City Manager is hereby authorized and directed to execute such Consent to Assignment and the City Clerk is directed to attest to his signature.
