APPROVING AN AGREEMENT BETWEEN THE CITY OF DES MOINES AND THE CITY OF WEST DES MOINES PROVIDING FOR TEMPORARY CLOSURE AND DETOUR OF WALNUT CREEK TRAIL NEAR 63RD STREET AND GRAND AVENUE

WHEREAS, the Grand Avenue Siphon Replacement Project is a public improvement project undertaken by the City of West Des Moines (WDM), the construction of which is scheduled to commence in the fall of 2016 on the Des Moines side of the intersection of Grand Avenue and 63rd Street; and

WHEREAS, the construction of said Project will require portions of the Walnut Creek Trail ("Trail") to be temporarily closed; and

WHEREAS, the City and WDM agree that it is of mutual benefit to the citizens of each community that said Trail be detoured during the construction of the Project; and

WHEREAS, the City shall agree to allow WDM to temporarily close those portions of the Trail used for the construction of the Project and detour the Trail along 56th Street and Waterbury Circle from November 1, 2016 through February 28, 2017.

WHEREAS, City staff and WDM staff have negotiated an Agreement for the Temporary Closure and Detour of the Walnut Creek Trail Near 63rd Street and Grand Avenue, a copy of which is on file in the City Clerk's Office.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa that the above described Agreement for the Temporary Closure and Detour of the Walnut Creek Trail Near 63rd Street and Grand Avenue, a copy of which is on file in the City Clerk's Office, is hereby approved and the Mayor is authorized and directed to sign said Agreement on behalf of the City and the City Clerk is hereby directed to attest to said signature.
