WHEREAS, on September 12, 2016, under Roll Call No., plans, specifications, form of contract documents, and Engineer's estimate of construction cost were filed with the City Clerk for the construction of the following improvement:

Ewing Park Lilac Plaza, 11-2015-010

The improvement includes placement of fill, rock subbase, Portland Cement Concrete (PCC) paving, erosion control, seeding, restoration and other incidental items; all work in accordance with the contract documents including Plan File Nos. 576-063/090, in Ewing Park, Des Moines, Iowa

WHEREAS, notice of the hearing on the plans, specifications, form of contract documents, and Engineer's estimate of construction cost was published as required by law; and

WHEREAS, the Des Moines City Engineer, as the Engineer, recommends rejection of all bids because no bids were received. In addition to distributing bidding documents to seven Plan Rooms, only three contractors obtained bidding documents. Staff contacted contractors and they noted the project was bid late in the season and makes it difficult to complete the work before anticipated weather changes while they are also trying to complete their existing projects, and given the smaller project size the risk of completion outweighed bidding on the project. Staff will review the project and completion options prior to considering rebidding of the project.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the hearing on the plans, specifications, form of contract documents, and Engineer's estimate of construction cost for said improvement be and is hereby **CLOSED**.
