SET HEARING FOR VACATION OF A PORTION OF ALLEY RIGHT-OF-WAY ADJOINING 1605 WOODLAND AVENUE AND CONVEYANCE OF A PERMANENT EASEMENT FOR BUILDING ENCROACHMENT TO OYORAM VISUAL ARTIST, L.L.C., FOR \$50.00

WHEREAS Oyoram Visual Artist, L.L.C., the owner of 1605 Woodland Avenue, has offered to the City of Des Moines, Iowa, ("City") the purchase price of \$50.00 for the purchase of a Permanent Easement for Building Encroachment in a segment of alley right-of-way adjoining 1605 Woodland Avenue (hereinafter "Property") in order to mitigate an existing building encroachment into the Property, which price reflects the fair market value of said portion of vacated alley right-of-way as currently determined by the City's Real Estate Division; and

WHEREAS, the Property proposed to be vacated and conveyed has been determined by the City Engineer and City Traffic Engineer to have no significant impact on public access, there is no known current or future public need for the alley right-of-way proposed to be vacated, and the City will not be inconvenienced by the vacation and conveyance of said City Property.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that:

1. That the City Council of the City of Des Moines, Iowa, shall consider adoption of an ordinance permanently vacating a 1-foot by 100-foot segment of alley right-of-way adjoining 1605 Woodland Avenue, as legally described below:

THE SOUTH 1 FOOT OF ALLEY RIGHT OF WAY LYING NORTH OF AND ADJOINING LOTS 1 AND 2 IN SUBDIVISION OF LOT 4 OF 4.94 ACRES OF THE PURSLEY ESTATE IN THE NORTHEAST ¹/₄ OF THE SOUTHEAST ¹/₄ OF SECTION 5, TOWNSHIP 78 NORTH, RANGE 24 WEST OF THE 5TH P.M., (ALSO KNOWN AS THE IOWA LOAN & TRUST COMPANY'S SUBDIVISION) ALL NOW INCLUDED IN AND FORMING A PART OF THE CITY OF DES MOINES, POLK COUNTY, IOWA.
