## APPROVING AN EXCEPTION TO THE PROCUREMENT ORDINANCE COMPETITIVE PROCUREMENT PROCESS FOR GOOD CAUSE AND APPROVING SUPPLEMENTAL AGREEMENT NO. 1 TO AGREEMENT FOR PROFESSIONAL SERVICES WITH OLSSON ASSOCIATES, INC. FOR ADDITIONAL SERVICES FOR DATA COLLECTION OF FIBER OPTIC EQUIPMENT STRUCTURE FOR THE ADDITIONAL AMOUNT NOT TO EXCEED \$68,888.17

WHEREAS, the MetroNet fiber optic system is jointly owned by the City of Des Moines, Iowa Communications Network (ICN), and the Des Moines Independent Public School District; and

WHEREAS, on March 21, 2016, by Roll Call No. 16-0483, the City Council approved the purchase of NetDesigner software which was the first step to developing a management system for the MetroNet fiber optic network; and

WHEREAS, on May 23, 2016, by Roll Call No. 16-0864, the City Council approved an exception to the Procurement Ordinance competitive procurement process for good cause and accepted the Olsson Associates, Inc. proposal to provide fiber network data conversion consulting and fiber management system training and authorized the Chief Information Officer to execute agreement for same; and

WHEREAS, Olsson associates has begun such work and has determined that discrepancies exist in various information sources used in the conversion and has submitted a proposal to the City for this supplemental work of collecting additional data for fiber network equipment structures and inputting the additional data into NetDesigner; and

WHEREAS, the City Manager recommends that the procurement of such consulting services be exempted from the competitive Request for Proposals process for good cause shown, pursuant to Section 2-710 of the Municipal Code of the City of Des Moines; and

WHEREAS, Olsson Associates, Inc. has submitted a proposal to provide such additional work in an amount not to exceed \$68,888.17 and City staff has prepared Supplemental Agreement No. 1, a copy of which is on file in the City Clerk's Office.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that good cause has been shown to exempt the procurement of supplemental work of collecting additional data for fiber network equipment structures and inputting the additional data into NetDesigner.
