**SETTING DATE OF PUBLIC HEARING AND APPROVING PUBLICATION OF  
NOTICE OF HEARING TO REVIEW AN APPLICATION FOR A STATE REVOLVING  
FUND LOAN AND TO REVIEW THE ANTICIPATED ENVIRONMENTAL IMPACT  
OF THE LOWER OAK PARK AND HIGHLAND PARK SEWER SEPARATION  
PROJECT**

**WHEREAS**, on December 21, 2015, by Roll Call No. 15-2106, the City Council of the City of Des Moines, Iowa, authorized the submittal of an application to the IDNR State Revolving Fund (SRF) for Lower Oak Park and Highland Park Sewer Separation Project (hereinafter "Project"); and

**WHEREAS**, before the City can proceed with the Project, pursuant to the requirements of the State of Iowa Clean Water State Revolving Fund loan program, the City must hold a public hearing to review an application for a State Revolving Fund loan, to inform area residents of the proposed Project, to discuss the potential environmental impact of the proposed Project to the community as determined by the State's Department of Natural Resources (DNR) Environmental Review, to discuss the City's facility plan for the Project, and to address area residents' concerns, if any, with the Project.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Des Moines, Iowa, that:

A public hearing shall be held on December 19, 2016, at 5:00 p.m. in the City Council Chamber, Richard A. Clark Municipal Service Center, 1551 E. Martin Luther King Jr. Parkway, Des Moines, Iowa.

The City Clerk is hereby authorized and directed to publish notice of said hearing twice: once before November 16, 2016, and again during the week of December 5, 2016. The publication by the City Clerk of the time and place of this public hearing, as required by the State of Iowa under its Clean Water State Revolving Fund loan program, is hereby approved.

The City Clerk is hereby instructed to place the City's facility plan for the Project and the preliminary Environmental Information Document(s) for the Project, upon receipt of said document(s) from the DNR, on file for public inspection in the City Clerk's office during the notice period until the public hearing is held.
