**AUTHORIZING SUBMITTAL OF FEDERAL SURFACE TRANSPORTATION
BLOCK GRANT (STBG) FUND FY 2021 APPLICATIONS TO THE
DES MOINES AREA METROPOLITAN PLANNING ORGANIZATION**

WHEREAS, The City of Des Moines is a full member of the Des Moines Area Metropolitan Planning Organization (MPO); and

WHEREAS, the Federal Surface Transportation Block Grant (STBG) Program provides funding to local jurisdictions for the construction of eligible projects; and also

WHEREAS, the programs are administered by the Des Moines Area MPO that prioritizes and ranks all project applications;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA, that the City Manager is hereby authorized to submit applications to the Metropolitan Planning Organization for Federal Surface Transportation Block Grant (STBG) funds for the following projects:

STBG Project Applications

1. Southeast Connector – SE 30th Street to US 65 Beltway (Roadway Project);
2. Walnut Street Bridge over the Des Moines River (Bridge Repair/Replacement Project);
3. Ingersoll Avenue Roadway Rehabilitation, 42nd Street to Polk Boulevard (Repair Project);
4. East Douglas Avenue - E 42nd St to E 56th St (Roadway Project)

BE IT FURTHER RESOLVED that if STBG funds are approved for one or more of these projects, the required local matching funds will be included in the future Capital Improvements Program, and the City will adequately maintain the project for its intended public use for a minimum of 20 years following the completion.
