BE IT FURTHER RESOLVED: That the Des Moines City Engineer, as the Engineer, has determined that the lowest responsive, responsible bid for the construction of said improvement was submitted by Stroh Corporation, Bob Blaskovich, Vice President, 5000 Park Avenue, Des Moines, IA, 50321 in the amount of \$368,209.00, and said bid be and the same is hereby accepted.
