## SET HEARING FOR CONVEYANCE OF CITY-OWNED PROPERTY LOCATED SOUTH OF AND ADJOINING 1429 9<sup>TH</sup> STREET TO SCOTT A. SLAUGHTER AND TODD D. SCHRODER FOR \$25.00

WHEREAS, on August 20, 1990, by Roll Call No. 90-3638, the City Council of the City of Des Moines, Iowa, approved and accepted a quit claim deed from Iowa Children's and Family Services a/k/a Children and Families of Iowa, an Iowa Non-Profit Corporation, conveying to the City of Des Moines, Iowa (hereinafter "City"), a strip of land for public alley purposes located south of and adjoining 1429 9<sup>th</sup> Street, Des Moines, Iowa; and

WHEREAS, said adjoining parcel at 1429 9<sup>th</sup> Street has an existing fence that encroaches onto a portion of the City's property and said portion of the City's property is not needed for public alley purposes; and

WHEREAS, Scott A. Slaughter and Todd D. Schroder, owners of the adjoining parcel at 1429 9th Street, have offered to the City the purchase price of \$25.00 for the purchase of a portion of the City's property (hereinafter "Property") for incorporation into their residential property in order to eliminate the existing fence encroachment, subject to the reservation of easements for all existing utilities in place, until such time that they are abandoned or relocated, which price reflects the fair market value of said portion of the property as determined by the City's Real Estate Division; and

WHEREAS, there is no known current or future public need for the Property proposed to be sold, and the City will not be inconvenienced by the sale of said Property.
