RESOLUTION APPROVING APPLICATION TO THE U.S. DEPARTMENT OF TRANSPORTATION (DOT) FOSTERING ADVANCEMENTS IN SHIPPING AND TRANSPORTATION FOR THE LONG TERM ACHIEVEMENT OF NATIONAL EFFICIENCIES (FASTLANE) PROGRAM FOR A RAIL PORT TRANSLOADING FACILITY IN THE CITY OF DES MOINES

WHEREAS, on October 20, 2014, by Roll Call No. 14-1667, the City Council received and filed the Des Moines Rail Transload Feasibility Study ("Transload Study"), as commissioned and approved by the Des Moines Area Metropolitan Planning Organization (MPO) to examine the need for a rail port or transload facility for transfer of shipments of products from one mode of transportation (rail or vehicular) to the other to assist and attract Des Moines area businesses transporting goods to and from the area; and

WHEREAS, on October 20, 2014, by Roll Call Nos. 14-1667 and 14-1668, the City Council approved various actions, including an agreement for professional services with McClure Engineering Company for development of request for proposals for the rail port transload facility and approving a letter of support to the Iowa Department of Transportation Railroad Revolving Loan and Grant Program; and

WHEREAS, the City's Office of Economic Development has determined that it would be beneficial to submit a Fostering Advancements in Shipping and Transportation for the Long Term Achievement of National Efficiencies (FASTLANE) grant application to the U.S. Department of Transportation for grant funding, in an amount not to exceed \$5,000,000, for development of the railport transloading facility; and

WHEREAS, if granted, the grant would require a forty percent (40%) or minimum estimated \$3,232,751 local match on a minimum estimated project cost of \$8,100,000, which local match is proposed to be met in part by the \$1,700,000 Rail Revolving Loan Grant Program (RRLG) loan already awarded for the proposed project, and through negotiation with a preferred provider for private capital contribution.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, that the Mayor is authorized to sign, and the City Manager is hereby authorized and directed to submit, the FASTLANE grant application in substantially the form on file in the office of the City Clerk; and the City Manager is directed to return the grant agreement, if awarded, to City Council for consideration and approval and for determination of the source of local match funds.
