**APPROVING AND AUTHORIZING THE EXECUTION OF AGREEMENT FOR COOPERATIVE PUBLIC SERVICE BETWEEN THE CITY OF DES MOINES AND THE DES MOINES INDEPENDENT SCHOOL DISTRICT FOR THE REMOVAL OF THE PEDESTRIAN BRIDGE CROSSING SOUTHWEST 9<sup>TH</sup> STREET AND CONSTRUCTION OF THE ASSOCIATED IMPROVEMENTS**

**WHEREAS**, The City of Des Moines must modify a school crossing used for access to Park Avenue Elementary School; and

**WHEREAS**, the Des Moines Independent School District has requested to participate in the project in order to better serve the needs of its students; and

**WHEREAS**, the City and the Des Moines Independent School District have negotiated an agreement stating the terms of this participation, subject to Council approval.

**BE IT RESOLVED** by the City Council of Des Moines, Iowa the Des Moines City Manager is hereby directed to:

1. That the Park Avenue Elementary School Crossing Agreement between the City of Des Moines and the Des Moines Public School District for the removal of the pedestrian bridge over Southwest 9<sup>th</sup> Street and construction of the site improvements, a copy of which is on file in the office of the City Clerk, is hereby approved as to form and content.






