The improvement includes installation of sanitary sewer service, water service, subdrain, drainage structures, and fire hydrant, along with Hot Mix Asphalt (HMA) and Portland Cement Concrete (PCC) pavement patching, PCC sidewalk, pavement removal, pavement markings, erosion control, site restoration, and other associated work and incidental items; in accordance with the contract documents, including Plan File Nos. 579-055/067, at Birdland Park and Marina, along Saylor Road from Birdland Marina to Guthrie Avenue, Des Moines, Iowa

BE IT FURTHER RESOLVED: That proposals will be received by the City of Des Moines, at the office of the Des Moines City Clerk until 11:00 a.m. on March 21, 2017, for the construction of said improvement, and the taking of bids in the manner required by law. Proposals received will be opened at a public meeting presided over by the Engineer in the Shijiazhuang Room, 2nd Floor, City Administration Building, 400 E. Court Avenue, Des Moines, Iowa, at 11:00 a.m. on March 21, 2017, after which the bids together with a bid tabulation and recommendation of the Engineer will be presented to the City Council at its next meeting for action thereon.
