APPROVING AN EXCEPTION TO THE PROCUREMENT ORDINANCE COMPETITIVE BIDDING REQUIREMENTS FOR GOOD CAUSE AND APPROVING A CONTRACT WITH CARPENTER UNIFORM & PROMOTIONAL PRODUCTS FOR THE POLICE & FIRE DEPARTMENTS

WHEREAS, Roll Call 07-053, dated January 8, 2007, approved a contract with Carpenter Uniform & Promotional Products, 5801 Thornton Avenue, Des Moines, IA 50321, to provide uniform services to the Police Department for good cause shown; and

WHEREAS, the Roll Call 07-769, dated January 8, 2007, approved a contract with Carpenter Uniform & Promotional Products, 5801 Thornton Avenue, Des Moines, IA 50321, to provide uniform services to the Fire Department for good cause shown; and

WHEREAS, the Police and Fire Departments wish to utilize the same contract for the same purposes and City staff have negotiated such contract with Carpenter Uniform & Promotional Products for an initial 1 year term with up to 4 one year renewal terms, a copy of which is on file in the City Clerk's Office; and

WHEREAS, the City Manager recommends that the procurement of uniform services for the Police and Fire Departments be exempted from the competitive bidding requirements for good cause shown, pursuant to Section 2-710(a) of the Municipal Code of the City of Des Moines; and

WHEREAS, funding in the amount of \$110,000.00 is available from Police Department operating budgets, and funding in the amount of \$55,000.00 is available from Fire Department operating budgets.

NOW, THEREFORE, BE IT RESOLVED, that the good cause has been shown to exempt the procurement of uniform services from the Procurement Ordinance competitive bidding requirements.

BE IT FURTHER RESOLVED that the Des Moines City Council hereby accepts and approves the procurement of uniform services for the Police and Fire Departments under the above described Carpenter Uniform & Promotional Products contract, a copy of which is in the City Clerk's Office, and the City Manager is authorized and directed to execute such contract on behalf of the City and renewals thereof.
