HEARING AND ADOPTION OF THE RECOMMENDED CAPITAL IMPROVEMENT PROGRAM PLAN FOR FISCAL YEARS 2017-2018 THROUGH 2022-2023

WHEREAS, the City Manager has submitted a recommended Capital Improvement Program (CIP) Plan which includes the Capital Improvement Plan for fiscal years 2017-2018 through 2022-2023 and includes the Capital Improvement Budgets for fiscal year 2016-2017, as amended, and fiscal year 2017-2018; and

WHEREAS, Section 384.15(3), Code of Iowa, requires a public hearing on the recommended Capital Improvement Program Plan prior to its adoption; and

WHEREAS, on February 20, 2017 by Roll Call No. 17-0270 the City Council set the public hearing to consider the City's recommended Capital Improvement Program Plan for the fiscal years 2017-2018 through 2022-2023 for March 6, 2017 at 5:00 p.m. in the Council Chambers in the Municipal Service Center and public notice of such hearing has been published as provided by law in the Des Moines Register on February 23, 2017; and

WHEREAS, those residents and taxpayers of the City interested in the City's recommended Capital Improvement Program Plan for the fiscal years 2017-2018 through 2022-2023, have been given an opportunity to present to the City Council objections to any part of the Plan and arguments in favor of any part of the Plan at this public hearing.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that:

- 1. Upon due consideration of all views and comments presented by City residents and taxpayers, the public hearing on the City of Des Moines recommended Capital Improvement Program Plan for the fiscal years 2017-2018 through 2022-2023 is hereby closed.
2. The City of Des Moines recommended Capital Improvement Program Plan for the fiscal years 2017-2018 through 2022-2023, including the Capital Improvement Budgets for fiscal year 2016-2017, as amended, and fiscal year 2017-2018, on file in the Office of the City Clerk is hereby approved and adopted.
