HEARING AND ADOPTION OF AMENDMENT TO THE  
ANNUAL BUDGET FOR THE CURRENT FISCAL YEAR ENDING JUNE 30, 2017

WHEREAS, further amendment to the City's annual budget for the current fiscal year ending June 30, 2017 is necessary to reflect changing estimates of revenue and expenditure appropriations relating to cash on hand at the end of the preceding fiscal year; of revenue and expenditure appropriations relating to amounts available from revenues other than property taxation and adjustments in expenditures across all programs; and transfers between funds and between programs; and

WHEREAS, the provisions of Chapter 384, Code of Iowa, require a public hearing on the amendment to the City's annual budget for the current fiscal year ending June 30, 2017; and

WHEREAS, on February 20, 2017 by Roll Call No. 17-0271, the City Council set the public hearing to consider the amendment to the City's annual budget for the current fiscal year for March 6, 2017 at 5:00 o'clock P.M. in the Council Chambers in the Municipal Service Center and public notice of such hearing has been published as provided by law in the Des Moines Register on February 23, 2017; and

WHEREAS, those residents and taxpayers of the City interested in the amendment to the City's annual budget for the current fiscal year ending June 30, 2017, have been given an opportunity to present to the City Council objections to any part of the amended budget and arguments in favor of any part of the amended budget at this public hearing.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that:

1. Upon due consideration of all views and comments presented by City residents and taxpayers, the public hearing on the amendment to the City of Des Moines annual budget for the current fiscal year ending June 30, 2017 is hereby closed.
